**CLASS REPRESENTATIVES' MOTION FOR APPROVAL OF  
FINAL PLAN OF ALLOCATION ORDER**

Pursuant to the September 30, 2024 Settlement Agreement<sup>1</sup> and the Court's February 7, 2025 Initial Plan of Allocation Order, Class Representative, Wake Energy, LLC, on behalf of itself and all others similarly situated, files this Motion for Approval of Final Plan of Allocation Order ("Motion"). In support of this Motion, Class Representative shows the Court the following:

1. Defendant deposited \$2,000,000.00, the Gross Settlement Fund, into the Escrow Account pursuant to the terms of the Settlement Agreement.
  
2. On February 2, 2025, the Court issued Orders Awarding Attorneys' Fees, Reimbursement of Litigation Expenses, and a Case Contribution Award, which approved the following:
  - a. Attorneys' Fees to Class Counsel in the amount of \$800,000.00;
  - b. Reimbursement of past Litigation Expenses to Class Counsel in the amount of \$24,705.51, but not exceeding the total noticed amount of \$39,000.00;

<sup>1</sup> All capitalized terms not otherwise defined herein shall have the meaning given to them in the September 30, 2024 Settlement Agreement, a copy of which is attached as Exhibit 1 to the *Memorandum of Law in Support of Plaintiff's Unopposed Motion to Certify the Settlement Class for Settlement Purposes, Preliminary Approval of Class Action Settlement, Approving Form and Manner of Notice and Set Date for Final Approval Hearing* that was filed on October 17, 2024.

- c. Payment of Administration, Notice, and Distribution Costs in the amount of \$52,423.30, but not exceeding the total noticed amount of \$130,000.00;
- d. A Case Contribution Award of \$39,000.00 to Class Representative.

3. In accordance with the Settlement Agreement and the above Orders, the foregoing amounts were distributed to the Class Representative and Class Counsel.

4. Following the foregoing Court-approved distributions, and reserving \$14,294.49 for potential future Litigation Expenses, and \$77,576.70 for Administration, Notice, and Distribution Costs, the Net Settlement Fund available for distribution to Class Members, plus the net accrued interest while in the Escrow Account, equals \$1,016,452.44.

5. The Final Plan of Allocation Order was prepared on behalf of the Class pursuant to the terms of the Initial Plan of Allocation Order and shows the proportionate settlement payments to be made to the Class in accordance with the Allocation Methodology previously approved by the Court. *See* Final Plan of Allocation (attached hereto as Exhibit 1).

6. As evidenced by the Final Plan of Allocation Order, the Parties and/or their agents have worked diligently to locate as many Class Members as possible, to update their information as necessary, and to calculate their interests consistent with the Settlement Agreement.

7. Upon the Court's approval, the distributions set out in the Final Allocation Order shall be made in accordance with the Initial Plan of Allocation Order. If payment cannot be made to 100% of the Class, any undistributed Net Settlement Funds will be handled as set forth in the Initial Plan of Allocation and the Settlement Agreement.


